Suncor Energy Products Inc. (Suncor) was issued a Renewable Energy Approval (REA) on August 22, 2014 in respect of the Suncor Energy Cedar Point Wind Power Project (the "project"). Information with respect to the decision on this project can be viewed on the Environmental Registry by searching EBR #012-0630

Suncor is proposing to make changes to the project and the project itself is subject to the provisions of the Environmental Protection Act of Ontario (Act) Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice is being distributed to make the public aware of **proposed changes to the project.**

Project Description and Proposed Change:

Pursuant to the Act and Regulation, the project in respect of which the REA was issued, is a Class 4 wind facility.

An application has been made to the Ministry of the Environment and Climate Change to **change the project** and alter the terms and conditions of the existing REA. The proposed changes consist of:

- 1. Suncor has assigned the project to the Cedar Point II Limited Partnership and is seeking to update the REA to reflect the new ownership of the project.
- 2. A text amendment to the REA to remove all references to "110 MVA" regarding transformers such that a spare transformer sourced for the project may be used at the facility. The spare transformer would meet or be below the sound power levels of the primary transformer which are specified in Schedule B of the REA.
- 3. An amendment to the REA to allow the Project to take more than 50,000L of water on any day for the purpose of construction dewatering of surface water. This requirement would be for select turbine foundation locations.

If approved with these changes, this facility would have a total maximum name plate capacity of 100 MW. The project location has not changed and, is shown in the map below.
