

Thank you for taking the time to provide us with feedback on our project. Your comments will form part of our consultation record.

As you correctly point out, much of the data available at our Open House is already available in the existing project documentation available on our website and at the local municipal offices and Strathroy library since July 2009. In addition to this information, the Open House is an opportunity to provide further information regarding wind energy in general and both NextEra and TCI Renewables – a large part of which is as you point out is similar to that available in the public domain. NextEra and TCI Renewables also had 10 staff members from both companies and 4 key personnel from our environmental consultants (Golder Associates) on hand to discuss the project in detail and answer questions about the project, the companies or wind energy in general.

The Open House is a central part of the consultation process, and is used to present the project information to as many stakeholders as possible and to obtain feedback. The Adelaide Wind Farm had been submitted under the old Environmental Screening Process and had almost reached full approval, when the Green Energy Act was introduced along with some new regulations (most notably the Renewable Energy Approval regulations or REA). As part of the previous process, TCI Renewables had undertaken two previous open houses in February 2008 and March 2009.

We reviewed the new REA requirements and made the appropriate amendments to the project design and incorporated any additional REA requirements to ensure compliance of the project under the new regulatory framework. The information provided at the Open House was intended to show these amendments and provide the wider public a chance to review the draft REA documentation for the project and provide feedback. We are required to consider any associated feedback in the drafting of our final REA submission.

Regarding the young lady with the light on her head, I agree with you that there was no relevance and would like to confirm that she was not connected with either NextEra Energy or TCI Renewables in any way and that her actions were not part of our information display.

You also requested additional responses on human health, property values and stray voltage. I have included a response from NextEra Energy Canada (our project partners) on these issues;

*NextEra Energy has never received a confirmed or documented claim of health effects from anyone, despite operating more than 8,500 wind turbines in the U.S. and Canada.*

*In 2009, a scientific advisory panel was commissioned by the American and Canadian Wind Energy Associations to review currently available literature on perceived health effects of wind turbines. The study "Wind Turbine Sound and Health Effects An Expert Panel Review" (December 2009) had the following key conclusions:*

- *There is no evidence that the audible or sub-audible sounds emitted by wind turbines have any direct adverse physiological effects*
- *The ground-borne vibrations from wind turbines are too weak to be detected by, or to affect, humans*
- *The sounds emitted by wind turbines are not unique. There is no reason to believe, based on the sound levels and frequencies of the sounds and the panel's experience with sound exposures in occupational settings, that the sounds from wind turbines could plausibly have direct adverse health consequences.*

*Stray voltage is not a wind energy issue but is related to electricity. In Ontario, stray voltage is addressed by the Ontario Energy Board, through an amendment to the distribution system code, as of June 16, 2009 (EB-2007-0709). This amendment requires a distributor to investigate complaints from farmers regarding stray voltage and all complaints should be addressed by the local distribution company. Primary sources of on-farm stray voltage are poor/faulty wiring, poor/improper grounding, unbalanced system loads, defective equipment or voltages from telephone or gas lines. The Adelaide Wind Farm project will be connecting to the transmission lines and not the local distribution system and the electrical collector lines will be designed to minimize any stray voltage potential. Thus it is highly unlikely that this project will increase or decrease the risk of stray voltage to consumers.*

*In response to the property value concern, there is no evidence that home prices surrounding wind facilities are consistently, measurable and significantly affected by either the view of wind facilities or the distances of the home to those facilities. It has not been NextEra's experience that property values have been impacted by*
