

My name is Ben Greenhouse, and I manage the environmental assessment and consultation processes at FPL Energy as they relate to the development of Wind Farms in Canada.

I have seen a copy of Chief Joseph's letter of February 5th, 2008 to NRCan and Environment Canada ("Wind Farms in Walpole Island First Nation Territory and the Need to Consult and Accommodate"), and understand the need to consult with WIFN in developments of this kind. FPL Energy, together with Canadian Green Power, has commenced the environmental screening process for four wind farms in Middlesex and Lambton Counties. To our knowledge, these projects are not on WIFN traditional territory. Unfortunately, the map of WIFN traditional territories that was attached to the letter was not included in the copy I received, so I cannot be sure. If it would be possible to receive a copy of the map for future reference, I would appreciate it. Regardless, I wanted to ensure that the WIFN was aware of our projects.

I have attached the notices of commencement we have issued that show the general locations of the areas of studies we have delineated. I would be happy to share further information on these projects if desired, but realize that you must be swamped with information at this point, so wanted to ensure that there was interest before sending over further information. I look forward to hearing from you.



Re: Wind Farms in Walpole Island First Nation Territory and Need to Consult and Accommodate

Dear Sirs:

Walpole Island First Nation is aware that a number of wind energy projects are being proposed throughout parts of WIFN's traditional territory in southwestern Ontario.

WIFN has the right to consultation and accommodation in respect of these wind projects, as they have the potential to impact WIFN's aboriginal and treaty rights and claims (including aboriginal title) in this area. WIFN is also interested in exploring potential opportunities for partnerships and other economic benefits from these projects.

WIFN holds treaty rights to some of its vast traditional territory, and has asserted claims in court for aboriginal title and rights to another large part of its territory.

WIFN holds a respected leadership role in environmental stewardship. It has much to share with federal and provincial governments and project proponents. WIFN takes this leadership role very seriously and wishes Canada and Ontario to understand, which we think is the case, that WIFN's voice about wind farm development is a voice that will contribute meaningfully to sustainable development of wind resources.

While WIFN was contacted about various wind projects, we, as with many First Nations, do not have the human resources or financial capacity to participate in meaningful and bona fide consultations and negotiations without support. This is especially so given the large number of wind projects and their various stages of advance. No such support has been offered or forthcoming from any affected government ministry. Further, to my knowledge, no separate process has been established to provide for consultation with and accommodation of WIFN in any substantive way in relation either to specific wind projects or wind energy development in our territory in general. As such, WIFN has not been adequately consulted or accommodated to date.

We therefore request the following:

- Immediate notification and description of the status of each project listed below (and any other proposed wind energy project in WIFN traditional territory, a map of which is provided). Such status reports should be directed to Dr. Dean Jacobs, Director of Walpole Island Heritage Centre, at 519-627-1530 (fax) and Dean.Jacobs@wifn.org.
- Commitment from each affected Ministry (federal and provincial) to appoint an appropriate representative to contact WIFN within the near future to set a date for a meeting between WIFN and these representatives, for the purpose of establishing a workable consultation and accommodation process or protocol and funding for same. Such individuals should contact Dr. Dean Jacobs at 519-627-1475 (phone) and Dean.Jacobs@wifn.org.

The wind projects in WIFN territory of which we are aware are:

- Port Alma Wind Power Project (Kruger Energy): 101 MW in Chatham-Kent
- South and East Lake St. Clair Wind Farm projects (AIM PowerGen Corporation): 80 and 150 MW in wind farms respectively
- Nine wind farms in southwest Ontario (Gengrowth Renewables Inc.): each with 4-6 turbines generating up to 10 MW
- Dover and Raleigh Wind Farms (Petawawa Renewable Power Corporation and Invenergy Services Canada ULC)
- Gosfield Comber Wind Energy project (Brookfield Energy).

Please contact Dr. Jacobs as soon as possible to arrange a meeting to discuss the consultation and accommodation process or protocol and funding. We also look forward to status reports for the above wind energy projects and any others in WIFN traditional territory.





I am writing to follow-up from my October 26, 2009 letter about the Bornish Wind Energy Centre.

We provided a copy of the October 26, 2009 "Bornish Wind Farm Project Draft REA Documents for Consultation" including appendixes with my letter. As you know, NextEra Energy Canada must file a final version of those documents with Ministry of the Environment to request a Renewable Energy Approval ("REA"), as described in Ontario Regulation 359/09. Since then, I understand a third party consultant has assisted in reviewing the Draft REA Documents, and a meeting has taken place with Aamjiwnaang staff and the consultant to discuss his draft report.

Under section 17 of that Regulation, NextEra is required to request a written response to our project proposal from your community. That is the purpose of this letter.

We respectfully request that at this time, you provide us with your written response to the Bornish Wind Energy Centre project proposal. We ask that your response include any information that you and/or your community feel should be considered as part of the reports to be submitted to the Ministry of the Environment for our Renewable Energy Application. This may include your views on:

1. Any anticipated adverse impacts our project may have on your constitutionally protected Aboriginal or treaty rights, and;
2. Any other concerns over potential negative impacts to the environment that you may have an interest in, and;
3. Any suggestions you have for mitigating the impacts identified in #1 and #2.

NextEra will include your response as part of its Aboriginal consultation program report, to be included in its submission for a Renewable Energy Approval for this project from the Ministry of Environment.

Our plan is to submit the Renewable Energy Application for this project by March 1, 2010.

Please be assured however, that NextEra representatives will be available to continue dialogue with you and/or your staff after this date, if you feel additional information is needed or if you have follow-up questions about our project.

In addition, we plan to continue providing updates and information to your community, throughout the project process.
