Thank you for your letter dated December 5<sup>th</sup>, 2012 and providing us with the comments and concerns identified by your Environment Committee. We greatly appreciate your interest in our project and the support of the Aamjiwnaang in conducting our work with Golder to date. We hope that similar arrangements can be made for future work, including post construction monitoring.

I have reviewed your comments with members of our team and would like to offer responses to comments and concerns raised. Please see below:

**Bird and Bat studies - including concerns with migratory bird paths such as tundra swans and geese):**

Throughout the regulatory and consultation process for our projects, we are continuing to gather feedback from local community members. We understand your concern about the potential impacts to birds. We take this issue very seriously. In fact, we have been active in understanding the relationship between birds and bats and wind turbines for some time. As early as 2004, Suncor participated and helped fund a research project conducted to identify and monitor the migratory behavior (flight paths and altitudes) of birds and bats using specialized radar-acoustic technology. Suncor continues to help fund other scientific researchers and have also been conducting extensive bird and bat studies for a number of years on our project sites. On many of our sites, we collect multiple years of data before constructing a project. For example, we collected bird and bat data for 3 years prior to constructing Wintering Hills - our newest wind farm just south of Drumheller, Alberta.

As we learn more about the flight patterns and behaviours of birds and bats we are beginning to see regulatory requirements placed on wind farms. For example, operational controls are now mandatory in Ontario as part of the Renewable Energy Approvals (REA) process - which was introduced as part of the new Green Energy and Economy Act. As part of the REA an

Environmental Effects Monitoring Plan (EEMP) report must be prepared as part of the Design and Operations report. The EEMP is reviewed by the Ministry of Natural Resources (MNR) and is required to identify the post construction monitoring plan, and if necessary post construction mitigation and operational mitigation and contingency plans in the event that monitoring shows unexpected results including mortality levels above prescribed limits. In addition, the EEMP must meet the requirements in the guidelines the MNR has developed for both bird and bats and bird and bat habitats for wind power projects.

As part of the Natural Heritage Assessment that is being completed for our Cedar Point Project (which has been provided to you for your review and comment), according to guidelines established by the MNR, Suncor is required to identify Significant Wildlife Habitat (including habitat related to Tundra Swans) and incorporate applicable setbacks and mitigation measures to such habitat in the design of the Project.

The Project Boundary is within 5 km of the Lake Huron shoreline and based on this there is potential for waterfowl stopover and staging areas to occur within the Project Boundary. The Thedford Flats Important Bird Area is located approximately 5 km from the Project Boundary and is known to support congregations of Tundra Swan; however, there are no known waterfowl stopover and staging areas within the Project Boundary. The only location found within the Project Boundary which had a congregation of Tundra Swans is the sewage lagoons west of the Town of Forest. While the sewage lagoons are not considered significant wildlife habitat (as they are non-natural features), we have identified this area in our design of the Project.

### **Potential vibrational and electrical impacts to earth worms and snakes**

Suncor and Stantec, who has been hired by Suncor to support the preparation of REA applications, have not been able to identify any scientifically reviewed information or documented accounts regarding potential impacts to earthworm or snake populations as a result of wind turbine operation including vibrational effects or electrical fields associated with power lines. Given the significant number of operational wind turbines worldwide, such documents would presumably be available if such impacts existed to earthworms and snakes.

### **Snake Species at Risk (SAR)**

Four species of at risk snakes (Butler's Gartersnake, Queensnake, Eastern Hog-nosed Snake, and Eastern Foxsnake) have been historically recorded within the general area of the Project. As a result, a site investigation field program was conducted to assess the potential presence of the species. Habitat for all four species was not found in the Study Area; therefore, the species and its habitat are considered absent from the Study Area. Installation of access roads, turbines and power lines is temporary and will not provide a barrier to potential snake movement. No impacts on SAR snakes from the operation of the Project are anticipated. Standard mitigation measures for working around water, as described in the Water Assessment and Water Body Report, should provide adequate protection in the unlikely event that a SAR snake is encountered.

## **Vegetation Restoration around turbine locations**

Suncor and Stantec have not been able to identify any scientifically reviewed information or documented accounts regarding unsuccessful vegetation restoration activities near wind turbines as a result of wind turbine operation including vibrational effects. In fact, normal farming practices such as crop production continue to take place up to the base of wind turbines once turbines become operational.

Suncor has constructed and operated wind power projects for 10 years and landowners with operating turbines have not reported loss of yield attributed to the operation of wind turbines.

## **Impacts to deer and deer paths and affects on hunting**

As documented in the Draft REA Reports, short-term impacts to game species such as deer may be encountered as a result of construction activities. However, current agricultural, recreational and hunting activities provide some disturbance, and none of the game species occupying the area are known to be particularly wary of human activity, so it is anticipated that they will adapt to the presence of operational turbines. This has been documented at many operational wind facilities within Ontario which routinely encounter deer activity in the area of operational wind turbines.

## **Plants and wetlands monitoring and maintenance**

As documented in the Draft REA Reports, monitoring of potential effects to significant natural features including wetlands is proposed along with contingency measures that will be implemented in the event that unexpected impacts are encountered. In addition, all areas that are impacted as a result of construction activities will be restored to its original condition (as confirmed in the Construction Plan Report). These restoration activities will also apply to the decommissioning of the Project.

## **Medical Issues and Shadow Flicker**

In 2012, Health Canada, in collaboration with Statistics Canada, announced that it will conduct a research study to explore the relationship between wind turbine noise and health effects reported by, and objectively measured in, people living near wind power developments. Suncor is supportive of additional peer reviewed scientific studies on the topic and is committed to improving our best practices of wind power project design and operation as these studies draw scientifically peer reviewed conclusions on the topic.

Ontario's Chief Medical Officer of Health in a report entitled "The Potential Health Impact of Wind Turbines" (May 2010), examined the scientific literature, including studies from Europe, related to wind turbines and public health, considering potential effects, such as dizziness, headaches, and sleep disturbance. The report concluded that:

*"...the scientific evidence available to date does not demonstrate a direct causal link between wind turbine noise and adverse health effects. The sound level from wind turbines at common residential setbacks is not sufficient to cause hearing impairment or other direct health effects, although some people may find it annoying".*

The report also concluded that low frequency sound and infrasound from current generation upwind model turbines are well below the pressure sound levels at which known health effects occur. Further, there is no scientific evidence to date that vibration from low frequency wind turbine noise causes adverse health effects.

With respect to shadow flicker, there are no current provincial guidelines for 'shadow flicker'. Individuals who are concerned about shadow flicker can contact Suncor directly at CedarPoint@suncor.com and we will undertake to review shadow flicker models for their location. Suncor will also implement best practices as identified by CanWEA to minimize the potential of these effects.

### **Cumulative impacts on wind patterns**

While wind turbines do temporarily change wind flows directly downwind of the rotor, Suncor and Stantec have not been able to identify any scientifically reviewed information or documented accounts regarding any changes to local or regional weather patterns as a result of operational wind turbines. Given the significant number of operational wind turbines worldwide, such documents would presumably be available if such changes to weather patterns existed.

### **Magnetic fields**

Suncor and Stantec have not been able to identify any scientifically reviewed information or documented accounts regarding magnetic fields associated with wind turbines or electrical infrastructure in general affecting plant and animal life including changes to growth rates or animal patterns. In fact, both electric and magnetic fields are naturally occurring in the environment and many bird species use electrical infrastructure for perching/nesting activities.

Our goal is to develop the best possible projects in a way that not only meets or exceeds all regulatory requirements, but also minimizes the impacts of our activities to our neighbours. Suncor, together with our consultants do review scientifically reviewed studies and documented occurrences of the issues you have raised (on impacts to earth worms, snakes, deer or wind patterns). If you are aware of any, please forward them to me for review. We respect the fact that there are differing opinions on the topic of wind power and we are committed to engaging with all community members in an open and respectful dialogue.
